## ABOUT CHEMICAL LEASING

Chemical Leasing (ChL) is a novel service-based business model that supports sustainable chemicals management and responds to the latest changes in international chemical policies. It closes the material cycles between suppliers and users of chemicals and provides economic and environmental benefits for the different partners involved.

In 2004, the Austrian Government and UNIDO decided to cooperate and promote Chemical Leasing at international level. Five years later, the German Government also joined this challenging global undertaking.

Chemical Leasing forms part of UNIDO's strategy to assist enterprises around the globe in all aspects related to the greening of industry.

The Chemical Leasing concept is currently being implemented in seven pilot countries (Colombia, Egypt, Mexico, Morocco, the Russian Federation, Serbia and Sri Lanka) in close cooperation with the respective National Cleaner Production Centres (NCPCs). Experience obtained in these countries shows that the ChL model has helped companies to reduce ineffective use and overconsumption of chemicals, develop partnerships with stakeholders and improve their economic performance.

In 2009, in order to enhance the visibility of Chemical Leasing worldwide, The Global Chemical Leasing Award was jointly developed by UNIDO and the Austrian Federal Ministry for Agriculture, Forestry, Environment and Water Management (BMLFUW).
